This executive summary of the School Accountability Report Card (SARC) is intended to provide parents and community members with a quick snapshot of information related to individual public schools. The data presented in this report are reported for the 2009–10 school year, except the School Finances and School Completion data that are reported for the 2008–09 school year. About This School

ABC was founded in 1987 by Joseph E. Morrow, Ph.D., B.C.B.A.-D and Brenda J. Terzich-Garland, M.A., B.C.B.A. to provide Applied Behavior Analysis services for persons with special needs. Applied Behavior Consultants, Inc., Inc. began by providing in-home behavioral services to the developmentally disabled population throughout northern and Central California. This included group parent training and behavior consultation to Community Care Facilities. We have provided behavioral services for over 3000 clients. Along with the continuation of these services, ABC opened its first classroom for children diagnosed on the autism spectrum in 1994.

ABC school is designed to meet the individual needs of children who are diagnosed with Autism or ASD (Autism Spectrum Disorder) between the ages of 3 and 12 years of age; for our NPS (Non Public School) in Sacramento the age of the child goes to 18. Intensive Behavioral Treatment (IBT) is provided within a **language-based ABA educational environment** where teaching is highly structured for acquisition of new skills. The teaching environment becomes less structured as the student demonstrates the use of skills learned in natural settings and across routines throughout the day. Within ABC's unique generalization framework, each child's curriculum teaches critical language skills, functional activities, socialization, initiation/spontaneity and generalization of mastered concepts/skills. These skills are built into every student's educational program and individualized to meet his or her learning style and unique needs. **The overall goal is to prepare the student for reintegration into his/her neighborhood school.**

Each classroom has a credentialed teacher, a lead behavior technician and a number of behavior technicians. In addition, a Senior Behavior Analyst or a Supervising Behavior Analyst (SBA) oversees every two classrooms of 10 students to provide on-going training, feedback and troubleshooting to teachers. To ensure the quality and effectiveness of each child's ABA educational curriculum, and to maintain a safe learning environment for each child and ABC staff, each site has two tiers of clinical administration and an HR department. ABC's classrooms provide a 1:1.5 technician to student ratio for student's age 3 to 9 and 1:2 ratio for students age 9 to 12. Initially, a newly enrolled student may receive 1:1 instruction until the teacher determines when and under what conditions the student will benefit from group instruction.

IX. Student Performance

Standardized Testing and Reporting Program

The Standardized Testing and Reporting (STAR) Program consists of several key components, including the California Standards Tests (CSTs); the California Modified Assessment (CMA), and the California Alternate Performance Assessment (CAPA). The assessments under the STAR program show how well students are doing in relation to the state content standards. The CSTs include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and nine through eleven. The CAPA includes ELA and mathematics in grades two through eleven, and science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations. The CMA is an alternate assessment that is based on modified achievement standards in ELA for grades three through nine, mathematics for grades three through seven and Algebra I and science in grades five, eight, and ten. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations. On each of these assessments, student scores are reported as performance levels.
